In exercise of the powers vested on him under Rule 20 of the Delegation of Financial Powers Rules, 1978 as amended from time to time, and in terms of Rule 6 of GIA Rules, 1996, the Lt. Governor, Andaman and Nicobar Islands (Administrator) has been pleased to accord sanction to release one time Grant-In-Aid of Rs. 1.25.00.000/- (Rupees **One Crore Twenty Five Lakh Only**) to ANIIDCO Limited for "Setting up of milk supply chain from Diglipur to Port Blair" during the year 2012-13 under Rastriya Krishi Vikash Yojana subject to the following conditions:-

1. The amount of Grant-in-aid should be utilized only for the purpose for which it is granted. Any part of the amount which is not ultimately required for expenditure on permissible head shall be remitted to the government account.
2. The accounts of the grant-in-aid be maintained properly and separately from its normal activities and submitted as and when required.
3. The audited statement of the accounts showing the expenditure incurred during the current financial year for which the grant is sanctioned should be furnished to the DAH & VS in duplicate as soon as possible after the closure of the financial year 2012-13.
4. ANIIDCO Limited should submit Utilization Certificate in Form-19-A as per the GFRs 2005 from time to time.
5. The assets acquired wholly or substantially by utilizing the Grant-in-Aid and except those declared as obsolete and unserviceable or condemned in the procedure laid down in the GFR, shall not be disposed of without obtaining prior approval of the authority which sanctioned the grants-in-aid.
6. ANIIDCO Limited should not divert the amount of grant-in-aid other than the purpose for which it has been sanctioned.

The expenditure is debitable to RKVY fund available with this Department for the year 2012-13 under the Major Head 2401 00 800 OE 800.36 RKVY 36.00.50. OC (ECR Code No. 5951)
