**NOTIFICATION**

Port Blair, dated the 2<sup>nd</sup> December, 2013

No.253/2013/F.No.8-305/Purchase/RKVY/DAH/2013.— In exercise of the powers conferred under Rule 20 of the Delegation of Financial Powers Rules, 1978, read with Rule 148 of General Financial Rules, 1963, the Lieutenant Governor (Administrator), Andaman and Nicobar Islands hereby makes the following rules regulating the procedure for sanction of the award of incentives to the Part Time Vaccinators engaged for Vaccination of Poultry Birds, namely :-

**1. Short Title and Commencement :**

- (i) These Rules may be called "The Rules for the award of incentives to the Part Time Vaccinators engaged for vaccination of Poultry Birds, 2013.
- (ii) They shall come into force with immediate effect.

**2. Definition :**

In these Rules unless the context otherwise requires :

- a) "Form" means a form prescribed for selection and engagement as Part Time Vaccinators and for grant of Incentives thereon.
- b) "Rules" means the rules framed for this specific purpose.
- c) "Register" means a register to be maintained by **Senior Veterinary Officer** indicating the name and details of vaccinators and register maintained for payment of Incentives.

**3. Procedure for selection of Vaccinators :**

- i) The beneficiaries will be selected by a Selection Committee consisting of the following members:

**(a) For Non-Tribal Farmers**

- ii) The following procedure will be observed for the selection of suitable candidates for Vaccination of Poultry Birds.

The Pradhan of the concerned Panchayat/Captain of the concerned village will call for a meeting of the Gram Sabha. The Senior Veterinary Officer concerned through the Pradhan/Village Captain will explain to the village about the objective and purpose of the project and then call for applications from those who are interested to be engaged as Part Time Vaccinators. Application shall be made on a plain paper/prescribed form alongwith certified/attested copy of proof of Address/Identity and shall be addressed to the Pradhan of concerned Gram Panchayat/Captain of the concerned village. The applications will be scrutinized by the Panchayat Secretary/Tribal Council Secretary in consultation with concerned Senior Veterinary Officer. The Director (AH/VS) shall have the right to approve or cancel the name of the candidate selected by the selection committee by recording the reason(s) for so doing in writing.

4. The selected Part Time Vaccinators will be imparted one week training on vaccination of Poultry Birds.
5. Minimum Qualification for selection of the Vaccinators is "VIII<sup>th</sup> Pass"
6. Incentive @ Rs. 2.00 Per Bird will be paid for vaccination of Poultry Birds.
7. After completion of the training whenever Poultry Vaccination programmes are undertaken the Part Time Vaccinator will be provided with a vaccination kit and the poultry vaccines in cold chain for carryingout the Poultry Vaccination.
8. The vaccination will be carriedout before dawn or at dusk/night in the house holds of the villages. The Poultry Vaccinator will be supervised by Para Veterinary Staff. The Part Time Vaccinator will maintain a record of Birds vaccinated along with the name and address of the house owner. Senior Veterinary Officer, In-Charge of the area shall maintain a register for each Part Time Vaccinator giving particulars of vaccine, date of vaccination, number of Birds vaccinated, kind of vaccine used and name and address of the owner of the Birds.
9. The Senior Veterinary Officer, In-Charge of the area shall submit the statement of Poultry Vaccination carriedout by each of the Part Time Vaccinators to the Directorate of Animal Husbandry and Veterinary Services with all the relevant details of payment of incentives to the Vaccinators.
